Whereas, the Government in the Urban Development Department vide Notification No. TPS-1484/CR-367/86/UD-1, dated the 16<sup>th</sup> January, 1987 has accorded sanction to the Development Plan and Development Control Regulations for Matheran Hill Station area (hereinafter referred to as "the said Development Control Regulations") under section 31 of the Maharashtra Regional & Town Planning Act, 1966 which have come into force with effect from 1<sup>st</sup> March, 1987;

And whereas, the Matheran Hill Station has many buildings and precincts of architectural, aesthetic & historical significance, tourists spots and a list of which has already been prepared by the INTACH on behalf of the Mumbai Metropolitan Regional Development Authority (hereinafter referred to as "the said Authority") and thereafter the Government vide communication dated 19/9/2003 issued directives to the Matheran Hill Station Municipal Council under section 37(1) of the said Act to incorporate the above list in the sanctioned Development Control Regulations of Matheran;

And whereas, Government vide Resolution No. TPS-1701/969 /C.R.168/01/UD-12, dated 16<sup>th</sup> June, 2010 has constituted Heritage Conservation Committee for Matheran Hill Station Municipal Council consisting of the 11 members in consultation with the Director of Town Planning, Pune for the period of 3 years;


