The hearing was again scheduled on Wednesday 08.04.2009 at 1600 Hrs. and both the parties i.e. BEAG and RPL were intimated to remain present for the hearing vide MMB letter no. MMB/Planning/RTI/621, dtd. 6.4.2009. The following personnel on behalf of BEAG and RPL attended the hearing conducted by Chief Executive Officer-cum-Appellate Authority with Chief Ports Officer-cum-Information Officer in attendance.

At the outset, Chief Executive Officer-cum-Appellate Authority heard both the parties.

Mr. Modi from BEAG requested for a copy of the BOOST Agreement (i.e. Concession Agreement) executed between Amma Lines Ltd. and Maharashtra Maritime Board for development of Rewas-Aware Port. He further stated that under Right to Information Act, 2005, anybody can ask for this information. BEAG wants to know the project details and the obligations with which M/s RPL and the State Government are bound by, because they think that there will be some issues arising out of it and also want to know environmental impact because it is an environmentally sensitive area. Mr. Mody also stated that this involves larger public interest.

Mr. Das from RPL stated that they have reservations for providing copy of the said BOOST agreement because it contains commercial and confidential information. He told the Appellate Authority that if a copy of Agreement is given to the BEAG, it will harm their commercial interest. There are other competitors in the area. Then he drew the attention to section 8(1)(d) of the RTI Act, 2005 which makes it clear that notwithstanding anything contained in the Act that the public authority shall be under no obligation to give to any citizen any information including commercial confidence, the disclosure of which, would harm the competitive position of the third party. He further stated that the applicant had not established that there is a public interest in asking for copy of this agreement.

-: DECISION:-

After examining the points raised by the appeallant in his appeal and giving hearing to both the parties, I hereby direct the Chief Ports Officer-cum-Information Officer, MMB to provide a copy of the Boost Agreement signed between Amma Lines Ltd. and Maharashtra Maritime Board to Bombay Environment Action Group in order to ensure transparency in the matter of infrastructure development in the area.
